8. TEACHING

(a) *Areas of special interest and accomplishments*

I have extensive experience teaching learners of all levels in a variety of different settings. In the course of my career I have used different teaching approaches, which include didactic lectures, small group learning and bedside teaching in direct patient care environments. My areas of interest are pharmacotherapeutics, pharmacy practice and critical appraisal. My clinical practice setting is Internal Medicine and I have taught a range of topics that fall within my practice area such as rheumatoid arthritis, electrolyte disorders, asthma, and chronic obstructive pulmonary disease. In addition, as I feel it is important for the students to have a clear understanding of the literature evidence behind therapeutic recommendations, I have incorporated critical appraisal into my lectures and conducted Integration Activities focused on this skill. For the learners that I teach in my clinical practice setting I utilize real patient cases to instruct them on therapeutics. I not only teach pharmacy learners but also consistently provide education to our medical and nursing colleagues at varying levels of experience.

I am the Respiriology Module Lead in the Entry-to-Practice Doctor of Pharmacy (E2P PharmD) curriculum and I am excited to be able to shape an integrated approach to this subject area. This module is in the second year of the E2P PharmD program in the second med man course, PHRM 211. As a significant contribution to the undertaking of the new program, I was involved in the pilot testing of this module in 2014W in the BSc(Pharm) program prior to implementation in the E2P PharmD program. I also

coordinate an elective course, PHRM 330 (formerly 450N) Introduction to Acute and Critically Ill Patients, which allows me the opportunity to bring topics I see in everyday practice to students.
